## Announcements -

A critical Service Providers Workgroup meeting will be held on Wednesday, October 27, at 2:00 pm on Zoom and the meeting will include the Needs Assessment consultants. Advanced registration is required for attendance. On Tuesday, October 26, there will be a Master Plan for Aging SF regional forum event on zoom from 1 pm - 3 pm. The event will focus on ending homelessness amongst for seniors and people with disabilities. Panelist will include Kelly Dearman and Shireen McSpadden along with a couple of other people. Registration is required for attendance to this meeting.

The Senior Disability Action (SDA) is hosting a virtual senior and disability university about social media advocacy and digital access starting next week. Some devices and a lot of training will be available for people who need them. A survey is being sent out to gather people stories to be able to show how important it is for remote participation options for phone and video continue even after people come in person to prevent less isolation.

On Wednesday, November 3, from 2:30 pm - 4:30 pm there will be a regional and statewide event about redistricting, concerning to get seniors and people with disabilities to fill out the senses. The next steps of looking at how the lines get drawn and what that means for our communities especially communities of color. We encourage people to submit their feedback during the forum.

The California Department of Public Health recently released their report on Alzheimer's and Dementia over the next two decades here in California. A study that shows 127% increase to be expected by 2040 in the number of people living with Dementia and Alzheimer's. It's an important study that breaks down the different counties to see how the different counties will be affected over the next two decades.

On Wednesday, October 27, from 10:30 am - 1:30 pm the SF Chinatown Community Resource Fair is hosting an event at Portsmouth Square. In attendance will be 30 or 40 different CBO's and the expected people attending will be 400.
