The Department of Disability and Aging Services (DAS) requests authorization to enter into a grant agreement with the Bayview Hunters Point Multipurpose Senior Services for the period of July 1, 2022 through June 30, 2025 in the amount of \$450,000 plus a 10% contingency for a total amount not to exceed \$495,000. The purpose of this grant is to provide outreach and culturally responsive nutrition support for older adults and adults with disabilities.

Background

DAS coordinates and funds a broad array of nutrition and food assistance programs for older adults and adults with disabilities living in the community. The programs promote health and wellbeing, and combat food insecurity by providing wholesome foods, meals, nutrition education, and nutrition counseling.

Despite the department's considerable reach through multiple and diverse community nutrition partners, some San Francisco communities find accessing nutrition and food assistance programs challenging. The COVID-19 pandemic highlighted the importance of tailored outreach and the development of new partnerships that address barriers to accessing DAS services for older adults and adults with disabilities of all cultural backgrounds. The pandemic brought about new partnerships and connections among community organizations that strengthened the City's efforts as a whole in addressing food insecurity for at-risk populations including DAS consumers. Many of these new community partners are trusted voices in their communities, such as neighborhood associations, and faithbased organizations and leaders and have been able to provide culturally appropriate outreach. By leveraging their established relationships with older adults and adults with disabilities, these new partners have introduced and connected their clients to the DAS-funded resources they needed. Ongoing collaboration with these types of community organizations will enhance the department's outreach efforts and strengthen its ability to serve consumers with cultural competency.

Services to be Provided

The grantee, in collaboration with the African American Faith Based Coalition, will conduct outreach and provide older adults and adults with disabilities living in the City and County of San Francisco with nutrition services. Outreach will focus on connecting with eligible consumers who are unaware of DAS nutrition services or find accessing food assistance programs challenging. Nutrition services will include meals, nutrition education, nutrition risk screening, and food security screening. The meals provided by the grantee may be breakfast, lunch, or dinner meals. The meals will meet nutritional standards by incorporating the Dietary Guidelines for Americans and each meal will provide a minimum of one-third of the Dietary Reference Intakes (DRIs). The meals will be prepared in accordance with nutrition and food service standards set forth by California Retail Food Code (CRFC), Title 22 Regulations, California Department of Aging, and DAS Office of Community Partnerships (OCP).

Selection

Grantee selected through RFP #1013 issued in April 2022.

Funding

Funding for this grant is provided by Dignity Funds.

Appendix A - Services to be Provided Bayview Hunters Point Multipurpose Senior Services

Bayview Culturally Responsive Nutrition Services July 1, 2022 – June 30, 2025

I. Purpose

The purpose of this grant is to provide culturally responsive nutrition services for older adults and adults with disabilities living in the City and County of San Francisco. Services will include culturally responsive meals, culture specific nutrition education, nutrition risk screening, and food security screening. Culturally responsive nutrition services empower individuals to maintain cultural integrity while accessing services they need to live independent and healthful lives in the community.

II. Definitions

Adult with a Disability	A person 18-59 years of age living with a disability.
At Risk of Institutionalizat ion	To be considered at risk of institutionalization, a person must have, at a minimum, one of the following: 1) functional impairment in a minimum of two Activities of Daily Living (ADL): eating, dressing, transfer, bathing, toileting, and grooming; or 2) a medical condition to the extent requiring the level of care that would be provided in a nursing facility; or 3) be unable to manage his/her own affairs due to emotional and/or cognitive impairment, evidenced by functional impairment in a minimum of three Instrumental Activities of Daily Living (IADLs): preparing meals, managing money, shopping for groceries or personal items, performing housework, using a telephone.

DGA/Dietary Guidelines for Americans	Evidence-based food and beverage recommendations for Americans ages two (2) and older that aim to promote health, prevent chronic disease, and help people reach and maintain a healthy weight. Published jointly every 5 years by the U.S. Department of Health and Human Services (HHS) and the U.S. Department of Agriculture (USDA).
DRI/ Dietary Reference Intakes	Nutrient reference values published by the Institute of Medicine (IOM) that represent the most current scientific knowledge on nutrient needs of healthy populations.
Disability	Mental, cognitive and/or physical impairments, including hearing and visual impairments, that result in substantial functional limitations in one (1) or more of the following areas of major life activity: self-care, receptive and expressive language, learning, mobility, and self-direction, capacity for independent living, economic self-sufficiency, cognitive functioning, and emotional adjustment. Food Security Screening	A screening to determine if an individual is experiencing food insecurity. LGBTQ+	An acronym/term used to refer to persons who self-identify as non-heterosexual and/or whose gender identity does not correspond to their birth sex. This includes, but is not limited to, lesbian, gay, bisexual, transgender, genderqueer, and gender non-binary.
Limited English- Speaking Proficiency	Any person who does not speak English well or is otherwise unable to communicate effectively in English because English is not the person's primary language.

Menu Planning and Analysis	The development of a menu cycle that adheres to DAS OCP and CDA menu standards and the nutrition requirements of meals. A Registered Dietitian conducts the menu analysis, and the analysis will demonstrate adherence to the menu standards and nutrition requirements of the meals. (CDA Program Memo 21-19 as amended)
Nutrition Counseling	Provision of individualized advice and guidance to individuals who are at nutritional risk because of their health or nutritional history, dietary intake, medications use, or chronic illnesses about options and methods for improving their nutritional status, performed by a registered dietitian in accordance with Sections 2585 and 2586, Business and Professions Code. (CCR Title 22 Sec. 7630)
Nutrition Education	Informing recipients of congregate and home-delivered meals about current nutrition facts and information, which will promote improved food selection, eating habits, nutrition, health promotion, and disease prevention practices. (CCR Title 22 Sec. 7630 & 7638.11)
Nutrition Requirements of Meals	Each meal provided through congregate and home-delivered nutrition services shall adhere to the current Dietary Guidelines for Americans (DGA) and provide a minimum of one-third of the Dietary Reference Intakes (DRI). (CCR Title 22 Sec. 7638.5)

Nutrition Screening	Completion of a nutrition screening checklist by eligible individuals to determine if they are at nutrition risk. A nutrition screening checklist is a federal public information collection requirement in the National Aging Program Information System (NAPIS), found in the Federal Register, Volume 59, No. 188, September 29, 1994. (CCR Title 22 Sec. 7630)
Nutrition Services	The procurement, preparation, transport, and service of meals, nutrition education, nutrition screening, and nutrition counseling, to eligible individuals at congregate sites or in their homes. (CCR Title 22 Sec. 7630)
OCP	Office of Community Partnerships.
OCM	Office of Contract Management, San Francisco Human Services Agency.
Older Adult	A person who is 60 years of age or older, used interchangeably with the term "senior".

III. Target Population

The target population is older adults and adults with disabilities living in the City and County of San Francisco who are unaware of DAS nutrition services or find accessing food assistance programs challenging. In addition, the grantee shall design services to engage one or more of the following target populations, which have been identified as demonstrating the greatest economic and social need:

- A. Persons with low income
- B. Persons who are socially isolated
- C. Persons with limited English-speaking proficiency
- D. Persons from communities of color
- E. Persons who identify as LGBTQ+
- F. Persons at risk of institutionalization

IV. Eligibility for Services

- A. An older adult or an adult with a disability, and
- B. A resident of the City and County of San Francisco.

V. Location and Time of Services

The grantee will provide nutrition services in the City and County of San Francisco. The grantee, with approval from DAS OCP, will determine the location(s) and the time(s) of service.

VI. Description of Services and Program Requirements

- A. Grantee in collaboration with the African American Faith Based Coalition (AAFBC) will outreach to the target population.
- B. Grantee will provide culturally responsive nutrition services to eligible consumers. Services will include and are not limited to the following:
 - 1. Culturally relevant meals. The grantee will provide eligible consumers with one meal per day. The meals may be hot, cold or pre-prepped. The grantee must ensure the type of meal provided aligns with the capacity of the consumer for safe consumption. The meals will meet nutritional standards by adhering to the current DGA and offer a minimum of one-third of the DRIs. DAS OCP must approve the provision of more than one meal per day per consumer. If the grantee provides two meals per day, the meals must contain at least two-thirds of the DRIs. If the grantee provides three meals per day, the meals must contain 100% of the DRIs. The grantee may not count fractions of meals or snacks cumulatively.
 - 2. Nutrition education. Nutrition education will be culturally relevant and provided quarterly.
 - 3. Annual nutrition screenings for each consumer and documentation of individual responses in CA-GetCare within one month of obtaining them. Required screenings include a nutritional risk screening using the

DETERMINE Checklist and a food security screening. The grantee will refer clients screened at high nutritional risk to the DAS funded citywide nutrition counseling and education program.

- C. Grantee will provide culturally relevant meals from a cycle menu they have created. The grantee will submit the cycle menu for review and approval by DAS OCP each fiscal year by a mutually agreed upon date between DAS OCP and the grantee. The grantee will submit the cycle menu at least one month in advance of use. The cycle menu must be at least five (5) weeks and culturally relevant for the target populations served. The grantee may revise the cycle menu based on consumer feedback and must submit the revised cycle menu for review and approval by DAS OCP at least one month in advance of use. A registered dietitian (RD) on staff or consultant RD must participate in menu planning and complete the corresponding nutrient analysis. If the grantee does not follow the cycle menu on any day, completely or in part, the grantee will document each menu substitution made. The documentation will include the date, the menu item not served and what food(s) replaced it.
- D. Grantee will inform consumers about the suggested voluntary contribution for a meal. Informing consumers includes posting a notice at a meal site and providing consumers notification with their meals. The grantee's board of directors must approve the suggested contribution and guest fee per meal. The grantee will ensure its policy and procedures for the suggested meal contribution and guest fee comply with DAS OCP policy memoranda.
- E. Grantee will have a qualified manager on staff who conducts the day-to-day management and administrative functions of the nutrition program. The grantee will ensure the manager on staff possess a food safety manager certification and has the required qualifications as described in the CCR Title 22 Regulations Sec. 7636.3 and DAS OCP policy memoranda.
- F. Grantee will monitor for safe food handling and sanitation practices at least once per fiscal quarter and at minimum four times per fiscal year
- G. Grantee will provide a minimum of four (4) hours of in-service trainings for paid and volunteer food service staff. Training, at a minimum, shall include the following topics: food safety, prevention of foodborne illness, HACCP principles, accident prevention, and instruction on fire safety, first aid, choking, earthquake preparedness, and other emergency procedures.
- H. Grantee will ensure there is a sufficient number of qualified staff, paid and volunteer, with the appropriate education, experience, and cultural competency to carry out the requirements of the program and deliver quality services to meet the needs of consumers.
- I. Grantee will attend in-service trainings and nutrition meetings coordinated and provided by DAS OCP, and share the information with their staff and volunteers as needed.
- J. Grantee will administer an annual consumer satisfaction survey that at minimum captures consumer feedback related to the outcome objectives for the program and on the quality of the services received. DAS OCP must approve the survey tool used by the grantee. The grantee will share the survey results with DAS OCP by March 15 each grant year or on a mutually agreed upon date between DAS OCP and the grantee.

K. Grantee will arrange for the availability of meals and/or food to participants during a major disaster where feasible and appropriate.

VII. Service Objectives

A. Grantee will enroll at minimum the number of unduplicated consumers and provide the units of service detailed in Table A below:

VIII. Outcome Objectives

- A. Consumers feel less worried about getting enough food to meet their needs. Target: 85%.
- B. Consumers rate the quality of meals they received as excellent or good. Target: 85%.
- C. Consumers feel the nutrition support they receive is inclusive of their cultural food preferences. Target: 85%.
- D. Consumers feel safe and welcomed by program staff. Target: 85%.

Based on a consumer survey and a sample size of at least forty percent (40%) of the enrolled unduplicated consumer.

IX. Reporting and Other Requirements

- A. Grantee will enroll eligible consumers into the program funded through this grant agreement by entering the consumer data obtained from consumers using the DAS OCP approved intake form, which includes the annual nutrition risk screening, and the food security screening into the CA-GetCare database in accordance to DAS OCP policy memorandum.
- B. Grantee will enter into the CA-GetCare Service Unit section all service objectives by the 5th working day of the month for the preceding month.
- C. Grantee will enter monthly reports and metrics into the CARBON database system by the 15th of the following month that includes the following information:
 - 1. Number of unduplicated consumers served
 - 2. Number of meals prepared and served
 - 3. Number nutrition compliance units provided
- D. Grantee will submit HACCP monitoring reports of the production kitchen and congregate sites to DAS OCP once per quarter. Quarterly reports due Oct. 15; Jan. 15; April 15; and June 15.
- E. Grantee will enter the annual outcome objective metrics identified in Section VIII of the Appendix A in the CARBON database by the 15th of the month following the end of the program year.

- F. Grantee shall issue a Fiscal Closeout Report at the end of the fiscal year. The report is due to SF-HSA no later than July 31 each grant year. The grantee must submit the report in the CARBON system.
- G. Grantee shall develop and deliver bi-annual summary reports of SOGI data collected in the year as requested by SF-HSA, DAS, and OCP. The due dates for submitting the bi-annual summary reports are July 10 and January 10.
- H. Grantee shall develop and deliver ad hoc reports as requested by SF-HSA, DAS, and OCP.
- I. Grantee program staff will complete the California Department of Aging (CDA) Security Awareness Training on an annual basis. The grantee will maintain evidence of staff completion of this training.
- J. Grantee shall be compliant with the Health Insurance Portability and Accountability Act of 1996 (HIPAA) privacy and security rules to the extent applicable.
- K. Grantee will develop a grievance policy consistent with DAS OCP policy memorandum.
- L. Grantee will assure that services delivered are consistent with professional standards for this service.
- M. Grantee shall follow guidance or instructions from the Centers for Disease Control and Prevention (CDC), California Department of Public Health (CDPH), and local health departments related to the provision of services in the community. If there are contradictory requirements between the most current CDC, CDPH, and local health department guidance or health orders, providers should follow the strictest requirements. The grantee shall follow the requirements with the intent to maximize the health and safety of their staff and clients receiving services.
- N. Pursuant to California Department of Aging Requirement, Grantor reserves the right to reduce funding available for this contract in the event that actual costs are below funding levels initially budgeted for the delivery of services.
- O. Through the Older Americans Act Area Plan development process, the City of San Francisco identifies "Focal Points" which are designed to help older adults and adults with disabilities connect to services throughout the City. These Focal Points are:

X. Monitoring Activities

- 1. Nutrition Program Monitoring: Program monitoring will include review of compliance to specific program standards or requirements; client eligibility and targeted mandates, back up documentation for the units of service and all reporting, and progress of service and outcome objectives; how participant records are collected and maintained; reporting performance including monthly service unit reports on CA-GetCare, maintenance of service unit logs; agency and organization standards, which include current organizational chart, evidence of provision of training to staff regarding the Elder Abuse Reporting; evidence of provision of the California Department of Aging (CDA) Security Awareness training to staff; program operation, which includes a review of a written policies and procedures manual of all DAS OCP funded programs, written project income policies if applicable, grievance procedure posted in the center/office, and also given to the consumers who are homebound, hours of operation are current according to the site chart; a board of directors list and whether services are provided appropriately according to Sections VI and VII, the log of service units which are based on the hours of scheduled activities; sign-in sheets of consumers who participated in each activity; documentation that shows reported units of service are based on scheduled activities at the site, not activities that are always available at the facility such as cards or pool; translation and social services are based on staff hours.
- 2. Fiscal Compliance and Contract Monitoring: Fiscal monitoring will include review of the Grantee's organizational budget, general ledger, quarterly balance sheet, cost allocation procedures and plan, State and Federal tax forms, audited financial statement, fiscal policy manual, supporting documentation for selected invoices, cash receipts and disbursement journals. The compliance monitoring will include review of the Personnel Manual, Emergency Operations Plan, Compliance with the Americans with Disabilities Act, subcontracts, MOUs, the current board roster and selected board minutes for compliance with the Sunshine Ordinance.
